Only proposals from those CONTRACTORS who are registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for Item B(A) "Asphalt Pavement - with Certified Hot Mix Asphalt (HMA) Plant" will be considered, unless the proposal specifically identifies the name and address of a subcontractor who shall perform the portion of the work along Park One Boulevard and S.R. 332. If applicable, the subcontractor shall be registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for Item B(A). In addition, only proposals from those CONTRACTORS who are registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for Item E(A) "Traffic Control: Signal Installation" will be considered, unless the proposal specifically identifies the name and address of a subcontractor who shall perform the portion of the work at S.R. 332 & W Jackson Street. If applicable, the subcontractor shall be registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for Item E(A). Any bids submitted by CONTRACTORS not approved for these items on the list will be returned to the bidder unopened.

The work to be performed and the proposals to be submitted shall include a bid for all general construction, labor, material, tools, equipment, taxes, permits, licenses, insurance, service costs, etc. incidental to and required for this project.

Each proposal must be enclosed in a sealed envelope with the supplied sealed bid notice, bearing the title of the project, bid opening date and the name and address of the bidder firmly attached. The proposal shall be accompanied by a certified check or acceptable *Bidder's Bond*, made payable to Delaware County

Redevelopment Commission, in a sum of not less than *ten percent* of the total amount of the proposal, which check or bond will be held by the said Delaware County as evidence that the bidder will, if awarded a contract, enter into the same with the OWNER upon notification from him to do so within ten days of said notification. Failure to execute the contract and to furnish performance bond to Delaware County Redevelopment Commission, will be cause for forfeiture of the amount of money represented by the certified check, or bidder's bond, as and for liquidated damages. Form 96, as prescribed by the Indiana State Board of Accounts, shall be properly completed, and submitted with bid proposals.

Proposals may be held by the Redevelopment Commission for a period not to exceed sixty (60) days from the opening date.

The successful Contractor will be required to furnish a Performance Bond in the amount of one hundred percent (100%) of the Contract price within ten (10) days after award of contract and a two (2) year Maintenance Bond in the amount of twenty percent (20%) of the contract price prior to completion and final payment of the contract.

The Standard Specifications are revised as follows:

SECTION 108, BEGIN LINE 3, DELETE AND INSERT AS FOLLOWS:

108.01 Subletting of Contract

The contract, contracts, or portions thereof; or the right, title, or interest therein shall not be sublet, sold, transferred, assigned, or otherwise disposed of without written consent. In case such consent is given, the Contractor will be allowed to sublet a portion thereof, but shall perform with its own organization, work amounting to not less than 5030% of the original or revised contract amount, whichever is less. All items designated in the contract as specialty items may be performed by subcontract. The cost of such specialty items so performed by subcontracts may be deducted from the total cost before computing the amount of work required to be performed by the Contractor with its own organization. No subcontracts or transfer of contracts will release the Contractor of liability under the contract and bonds. Approved subcontractors will not be allowed to further subcontract their work.

No questions will be answered by telephone. An Addendum will be issued that provides all questions received with answers as applicable. This Q and A Form is a material part of the contract. There may be questions shown on the Q and A Form without posted answers. Therefore, bidders are advised to prepare their bids based on the contract documents as issued.

Q: Thursday 4/24/2025

Upon reading the bidder requirements for this project, it appears only contractors who are prequalified with INDOT for Items B(A) and E(A) will be considered. Would you consider adding the prequalification codes C(B) light grading &/or E(E) small structures and drainage items? In looking at the pay items and drawings, it appears this job has quite a bit of grading as well as a structure with reinforced concrete box sections.

A: Tuesday 4/29/2025

Additional pre-qualification codes will not be added. However, the pre-qualification for Item B(A) "Asphalt Pavement – with Certified Hot Mix Asphalt (HMA) Plant" may be satisfied by a subcontractor identified in the Proposal. An adjustment for the minimum percentage of work required of the prime Contractor has been added.

Q: Tuesday 4/29/2025

MS-68 through MS-71 references the grooving of pavement markings. There is no pay item for Grooving of Pavement Markings. Can one be added?

A: Tuesday 4/29/2025

Yes, a pay item for grooving will be added.

Q: Tuesday 4/29/2025

MS-68 through MS-73 references Wet Reflective Optics. This Glass Bead is a product that has been used on INDOT projects since early 2023. This product does cost more than the standard performance bead and should only be used for longline markings within a groove. Are you wanting contractors to use this more expensive bead or the standard performance bead?

Pavement marking materials shall be in accordance with the Modifications to the Specifications as shown in the Contract Book.

Q: Tuesday 4/29/2025

Pay Item 67 is Temporary Pavement Marking 6 IN. Typically, this refers to Temporary Paint being used. The plans call out for Temporary Pavement Marking Removable, which would be temp tape. Could the pay item description be changed to reflect this?

A: Tuesday 4/29/2025

Pay Item 0067, 801-06206 Temporary Pavement Marking, 6 IN. will be deleted and replaced with 801-06209 Temporary Pavement Marking, Removeable, 6 IN.

Q: Tuesday 4/29/2025

The plan for Advance Signage Detail on Plan sheet 7 of 78 shows a Portable Changeable Message Sign prior to the Added Penalty Signs. There is no pay item for PCMS. How will this piece of equipment be paid for?

A: Tuesday 4/29/2025

A pay item will be added for Portable Changeable Message Sign.

Q: Tuesday 4/29/2025

How will the removal of existing markings as shown on the pavement marking sheets be paid for?

A: Tuesday 4/29/2025

Existing pavement markings that are in conflict with the maintenance of traffic layout shall be covered with Temporary Pavement Marking, Removable, Solid, Black of the width specified in the legend on Plan sheets 11-19.

O: Tuesday 4/29/2025

Blackout is mentioned several times in the MOT phases. How will this be paid for?

A: Tuesday 4/29/2025

Temporary Pavement Marking, Removable, Solid, Black will be paid for as Temporary Pavement Marking, Removable, 6 IN. regardless of width.
